The following are items for discussion and action at the August 8 LUC Executive Committee Meeting

### FY20 Planning Work Program Amendment

TCC Staff is requesting a Planning Work Program Amendment to the budget for the current fiscal year. The Planning Work Program approved by LUC in May included an estimate of \$50,000 in carry forward Statewide Planning and Research (SPR) funding that is available to be spent prior to the end of calendar year 2019. At the close of the state fiscal year, TCC staff determined the actual amount of funding available to carry forward to be \$53,000.

The proposed Resolution amends the current Planning Work Program by adding \$3,000 to work element 601.21 for Consultant Services activities. The grand total budget for the Planning Work Program will be revised accordingly to \$151,392.67.

Because the Planning Work Program is an LUC adopted document, TCC Staff requests amendment via Resolution.

### Indian Lake Traffic Study

In coordination with the Logan/Champaign Technical Advisory Committee, TCC Staff scoped a consultant services task order on June 28 to study 6 intersections on US33 in the Indian Lake sub area. Staff received a scope of services proposal and cost proposal on July 17 and is currently reviewing the scope and fee. The study is scoped as a continuation of the sub area study performed by TEC Engineering for the RTPO in 2016.

### **Other**

TCC Staff collected and compiled trail counts from counters placed on the Simon Kenton Trail in various locations in Logan and Champaign County. Data was transmitted to local partners and is available upon request.

TCC Staff participated in meetings to extend the US33 Smart Corridor from the TRC to SR274 through Shelby County to IR75. TCC Staff will begin working with a technical steering committee to refine scope of potential smart mobility projects with a goal to apply for an Advanced Transportation and Congestion Management Technology Deployment grant through the USDOT in mid 2020.

The next scheduled meeting of the Logan/Champaign Technical Advisory Committee is Tuesday, September 3 at 9:30AM at Consolidated Care in West Liberty.

**WHEREAS,** \$ 2,854.20 of Direct Labor, Fringe Benefits, and Indirect Costs will be moved to Direct Expense within work element 605.11 Surveillance; and

**WHEREAS,** this budget amendment totaling \$3,554.20 will result in no change to the Grand Total budget of \$ 143,219.67.

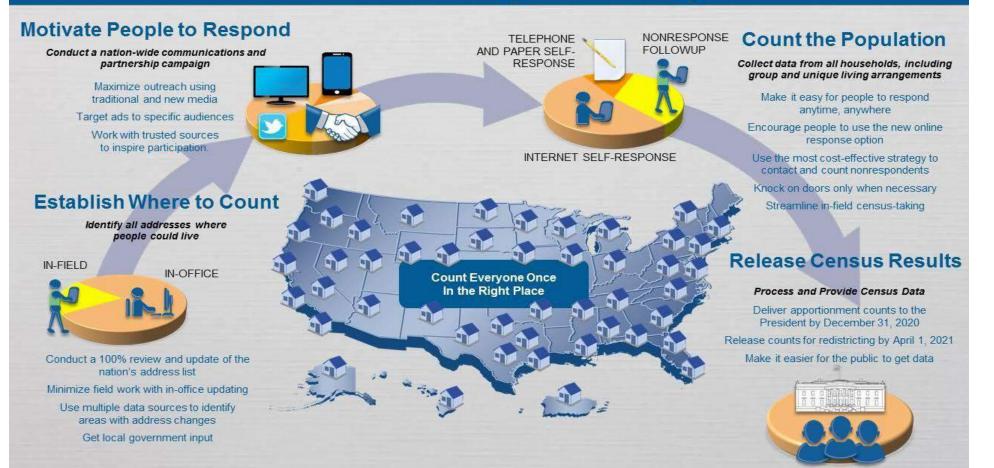

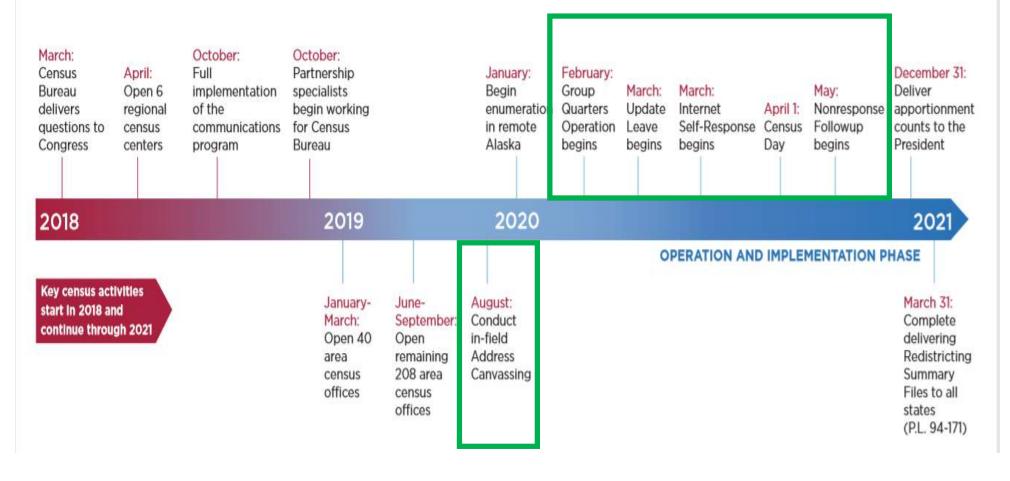

# Legal Confidentiality and Privacy

- ✓ All information collected by the Census Bureau under the authority of Sec. 9, Title 13 of the U.S. Code (13 U.S.C. 9) is strictly confidential. The same law that requires individuals to respond to the Census also guarantees the respondent's confidentiality.
- ✓ The law requires the Census Bureau to keep private citizen's information confidential and use their responses only to produce statistics and cannot share individual responses with anyone.
- ✓ Census workers must pass a security check, sworn to uphold a pledge of confidentiality, and the penalty is up to a \$250,000 fine and up to a 5-year prison term.

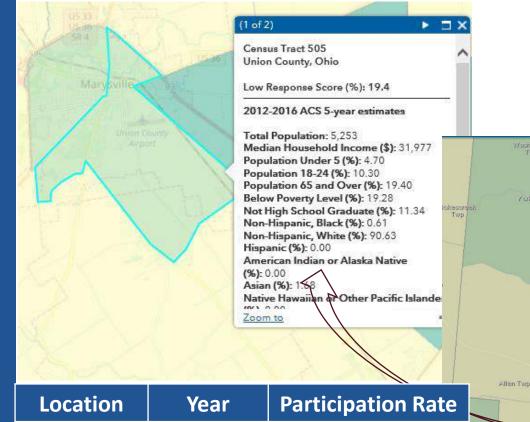

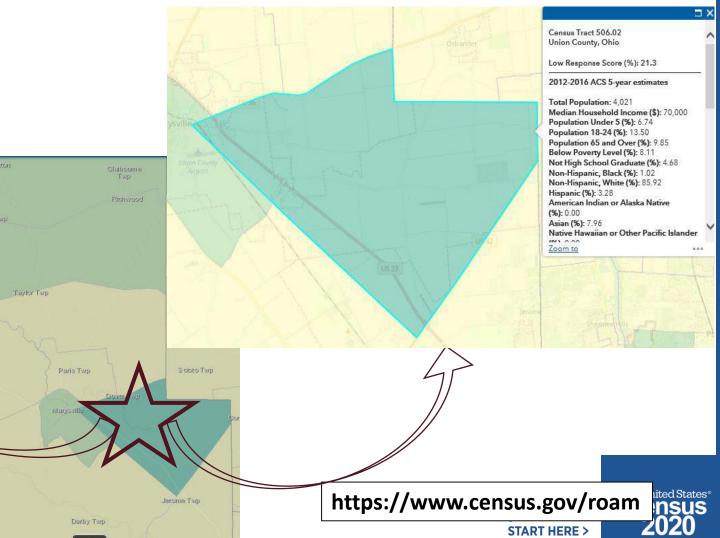

# Complete Count Committee (CCC)

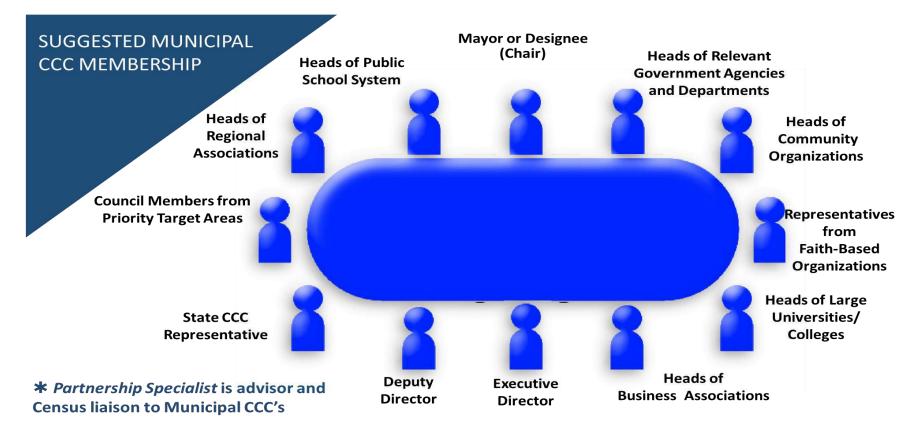
The Census Bureau has asked governments/organizations to set up a CCC if feasible. Establishing a CCC which represents a broad range of community interests, will play a major role in conducting census outreach and promotion activities for the community and its members.

### ✓ Three Phases:

- 1. Education Phase (Now September 2019)
- 2. Promotion Phase (April 2019 January 2020)
- 3. Motivation/Action Phase (February 2020 June 2020)

# What a CCC Does for a Community

- ✓ Increase the response rate for residents returning their questionnaire through a focused, neighbor-to neighbor program and continued awareness of the 2020 Census.
- ✓ Utilizes the local knowledge, expertise, and influence of each Complete Count Committee member to design and implement a census awareness campaign targeted to the community to impart that knowledge to the community.
- ✓ Bring together a cross section of community members whose focus is 2020 Census awareness that speaks the language of, knows the pulse of its community, and will help ensure an accurate 2020 Census count.
- ✓ When should a CCC organize? NOW



## **Collaborate with the Census Bureau**

### **Operational Support**

- ✓ Provide space that can be used for testing, on-boarding, training, etc.
- ✓ Provide lists of residential institutions
- ✓ Provide lists of shelters, service providers, and transient locations
- ✓ Promote temporary job opportunities

### **Promotional Support**

- ✓ Form a Complete Count Committee (elected officials, community groups, faith based, social service, health, business, etc.)
- ✓ Encourage census participation in newsletters, on websites, alert systems, drop-in articles, etc.
