If somebody else is doing something in the state, that makes sense, then it makes sense to evaluate what they're doing.</li> <li>Charles Hall – We only make recommendations, we don't make policy. Brad works very hard with the townships; economic development is not LUC's job. That's not the privy of LUC. That comes through the townships and cities, and we can only make recommendations, if they're brought to us.</li> <li>Andy Yoder – I think the membership should utilize LUC more. There's a wealth of information. We need to inform the membership that it's not just zoning, that there's vast information available.</li> <li>Charles Hall – Providing guidance, support, education, training local governments. These are the important things that LUC does. Brad did a great presentation on medical marijuana and making it available to the townships, which is extremely helpful to them.</li> </ul>

- Chad Flowers At the City, the IT department does that, but the data is from the county auditor's and engineer's office. We have an online map that I can use; or I can make one myself.
- Charles Hall We're basically three people; some of the abilities we need we don't have; if we want to increase it, then we need to look at that structure and look at those fees.
  - John Bayliss I'd rather get a contractor to tell us what we need.
    - Chad Flowers Union County has GIS information. Maybe you just have a link saying if you need this GIS information, refer people to go to the county for the GIS information.
  - Kevin Gregory The idea of being able to do this is great, they'll need an LUC as a data harvester; regarding the financial aspects, dealing with developers that don't know the rules, don't go to the right place; if we could charge developers for data; make it a pay for play.
    - Chad Flowers That makes me a little nervous as public agency and charging for public records.
  - Kevin Gregory It would be nice to have the rules in place, so if you want it done easily, you can go through LUC but it's going to cost.
    - Dave Faulkner if I want an answer, I want it now and not have to go talk to someone else. Maybe instead of hiring a new person, you free up some of Brad's time to allow him to do that.
- John Bayliss How can we partner closer with OSU on data?
- Dave Faulkner There are people who don't understand the purpose of this smart mobility
- John Bayliss Why not have a contract with the Department of Geography, maybe we need to have an intern all year along; I support the co-op ideas; I think it would be more than one way to tackle a resource.
- Charles Hall We can't be everything to everybody. We need to do what we can do and do it well and then we can branch out.
- Andy Yoder asked about Sufficient Economy in the Sustainability diagram; rewording may need to be changed.
- John Bayliss I think including the diagram to look at. I think before we get into goals, we need to do a SWOT analysis.
