Work Summary

Staff conducted corridor operational and safety analyses on the LOG US33/SR274 and LOG SR274/CR61 intersections, the CHP US68 corridor between SR55 and Campground Road, and the LOG CR5 and CR153 corridors in the village of Zanesfield. Video, traffic, and crash data was collected and analyzed for freight and speed issues and recommendations.

Staff coordinated with local stakeholders on the Indian Lake Sub-Area Study. The stakeholders continued to meet after completion of the study to address signage, traffic control, pedestrian, and vehicular speed issues.

Staff coordinated with City of Urbana staff on scoping several corridor studies, including CHP SR54 near Oakdale Cemetery, S. High Street, and CHP US68 near the new Urbana City Schools campus. These studies will be completed in FY2019.

Staff participated in District Safety Review Team meetings regarding ODOT safety hot spots on the US and State system, including LOG SR235/SR47 and CHP SR29/3 Mile Road. Staff reviewed crash data at safety hot spots at the request of local officials.

Staff assembled and coordinated an informal Technical Advisory Committee of local officials to prioritize and review planning activities. The committee met three times during this period.

In coordination with ODOT, staff began work on development of a Title VI Program and Policy for the RTPO. The final document is a FY2019 end product.

Staff participated in various OARC Committee meetings and various ODOT sponsored workshops and seminars.

Work Summary
Staff collected spot traffic counts utilizing video detection equipment and online processing. Staff collected video traffic data for analysis at several intersections in Logan County, Champaign County, and the Village of Zanesfield. Staff collected bicycle and pedestrian counts along several sections of the Simon Kenton Trail in Logan and Champaign Counties.

Staff sorted and reviewed 2014-2016 crash data and prepared the 2017 Local Roadway Safety Program. Included in the data are safety rankings for high crash intersections and all Federal-aid segments in the planning area.

Staff compiled and geocoded traffic data from various sources, including TIMS, into shapefiles. This data was used primarily for the Local Roadway Safety Program document.

The following are items for discussion at the September 13 LUC Executive Committee Meeting

Urbana SR 54 Curves Study

Burgess and Niple, acting as a consultant team for the TCC, finalized the SR54 Curve Signage Study on August 24. The report analyzed crash data and appropriate advisory speeds for the two curves near Oakdale Cemetery. The proposed short term improvements for the corridor include reduced advisory speeds, relocation of warning signs, and installation of properly spaced and sized chevrons and arrow signs. The report also recommends a high friction surface treatment as an additional improvement in the long term.

Urbana South High Street Corridor Study

TCC staff, with coordination from City of Urbana staff, prepared a scope and request for cost proposal from Burgess and Niple for a one mile corridor study on South High Street from US36 to SR55 in Urbana. The study will be focused on drainage, parking, bicycle and pedestrian, and intersection safety improvements. Initial cost proposal for the study is anticipated on September 7 with an estimated study completion date of December 31.

FY2020-2023 Rural Transportation Improvement Program

The Rural Consultation period for the FY2020-2023 Transportation Improvement Program will be held between September 10 and October 12. The Rural Consultation meetings provide an opportunity for ODOT, RTPO's, and local officials to discuss their current transportation plans and transportation improvement needs. All local County, Township, City, and Village officials, including engineering, planning, law enforcement, emergency services and transit officials are invited to meet with RTPO and ODOT staff to discuss the upcoming Transportation Improvement Program. FY2018 Planning Work Program Completion Report
