RTPO Technical Advisory Committee Monday, February 28, 2022

The Technical Advisory Committee was called to order at 9:30 am by Tyler Bumbalough.

New Business:

- 1. Welcome and Introductions were completed.
 - Scott Schmid has taken a position with ODOT and is no longer TCC Director. Scott reported Blake Simpson remains the LPA Coordinator, but Scott will likely be attending TAC meetings.
 - o Louis Agresta is Acting TCC Director.
- 2. November 1, 2021, Meeting Minutes
 - Scott Coleman moved a motion to accept the minutes as written and Steve McCall seconded. All in favor.
- 3. RTPO Capital Program and STBG Applications
 - o Scott Schmid gave the report, since he has recently left TCC and is starting at ODOT. Scott reported Logan 18 has a billing fund assigned. The Champaign County Engineer project also has a billing fund assigned. Blake Simpson is sending scope documents to jurisdictions. At this time, toll revenue credits are not an issue. The project point persons, at this time, are Tyler Bumbalough, Scott Coleman, and Steve McCall.
- 4. Project Updates
 - o St Paris/Champaign County Trail Feasibility Study
 - Louis Agresta reported this is wrapping-up and likely to be a March or April Executive Committee agenda item.
 - City of Urbana Miami Street Safety Study
 - Tyler Bumbalough reported the City is looking at a safety study prior to doing a paving program. This would look at intersections, striping, and two key intersections.

- 5. FY2023 Planning Work Program
 - Louis Agresta reported for this item. The budget currently anticipates a \$50,000-60,000 in carryforward; it is anticipated this will be split half labor and half Traffic Signal Inventory. A draft is due to ODOT March 4th. The City of Urbana is hoping to use some of the funds for a Traffic Signal Inventory; not wanting to consume all the funds, the City is OK with phasing this project if needed. The group discussed the importance of sharing funds with Logan County and the City of Bellefontaine, if a request for a project is made. The RTPO can fund feasibility studies, but not actual engineering.
- 6. 2050 Long Range Transportation Plan Update
 - Louis Agresta reported for this item. TCC will be starting this activity in 2022. Regina Rollins will be TCC's point person.
 - o Brad Bodenmiller volunteered to work with Regina to scope public participation from the PPP and discuss make-up of the Steering Committee. Maybe the TAC plus additional township/village representation and chamber/CEP representation makes sense since this is an update and not the inaugural document.
- 7. Mobility Management and Transit Updates
 - o There was no report on this item.
