**A RESOLUTION ADOPTING THE RECOMMENDATION OF THE RICHLAND TOWNSHIP ZONING COMMISSION TO AMEND THE OFFICIAL ZONING MAP**

WHEREAS, the Board of Trustees ("Board") of Richland Township is the legislative body of Richland Township, Logan County, Ohio, ("Township") which has enacted a Zoning Resolution pursuant to Ohio Revised Code Chapter 519;

WHEREAS, Ohio Revised Code Section 519.12 permits the Township to amend its official zoning map subject to review and recommendation from the Township Zoning Commission;

WHEREAS, the Township Zoning Commission held a public hearing May 16, 2023 to review the proposed map amendments in consultation with a representative from the Logan Union Champaign (LUC) Regional Planning Commission, and voted to recommend amendment to the Board, particularly as the current official map dates from 1987 and the proposed amendment more accurately reflects existing land uses in the Township and projected future land uses;

WHEREAS, the Board held a public hearing on the proposed map amendment on June 9, 2023 with no opposition from the public, and therefore finds it is in the best interest of the Township to adopt the proposed map amendment as recommended by LUC and the Zoning Commission;

NOW THEREFORE, BE IT RESOLVED by the Board of Trustees of Richland Township, Logan County, Ohio:

1. The map attached and incorporated as Exhibit A is hereby adopted as the Official Zoning Map of Richland Township, Logan County, Ohio.
2. The Chair of the Board and Fiscal Officer are authorized to execute any necessary documents and take action on behalf of the Township to record the amendment of the Official Zoning Map with the Logan County Recorder.
3. LUC is authorized to publish the Official Zoning Map in print and digitally.
