The following are items for discussion and action at the August 13 LUC Executive Committee Meeting

FY2020 Planning Work Program Amendment 3

TCC Staff is requesting a final amendment to the FY 2020 Planning Work Program. The amendment balances the previous fiscal year budget by moving funds between Work Element 601.2 – General Planning Services and Work Element 605.1 – Surveillance. The \$11,770 in changes results in no overall change to the grand total budget of \$151,392.67.

Because the Planning Work Program is an LUC adopted document, TCC Staff requests amendment via Resolution.

FY2021 Planning Work Program Amendment 1

TCC Staff is requesting a Planning Work Program amendment to the budget for the current fiscal year. The Planning Work Program approved by LUC in May included an estimate of \$23,998 in carry forward Statewide Planning and Research (SPR) funding that is available to be spent prior to the end of calendar year 2020. At the close of the state fiscal year, TCC staff determined the actual amount of funding available to carry forward to be \$50,000.

The proposed Resolution amends the current Planning Work Program by adding \$26,002 to work element 601.21 for consultant services activities. The grand total budget for the Planning Work Program will be revised accordingly to \$148,392.

Because the Planning Work Program is an LUC adopted document, TCC Staff requests amendment via Resolution.

2020 Public Participation Plan

The draft 2020 Public Participation Plan was published on the LUC website on July 31 and is in a mandated 45 day public comment period that will conclude on September 13. Citizens are encouraged to visit the website where there is a short prerecorded presentation and a comment form, along with the draft document.

Informational only, no action requested at this time. It is anticipated that a disposition of comments received will be presented to the Technical Advisory Committee on

September 14 and a final document will be presented for adoption at the October 8, 2020 LUC Executive Committee meeting.

Other

TCC Staff collected 24 hour turning movement counts on LOG SR287 at NEX and at CR153 the week of July 20. The counts were processed and forwarded to the Logan County Engineer and Logan County Chamber.

The next RTPO Technical Advisory Committee meeting will be held via Zoom on September 14 at 9:30 AM. Those interested in the meeting are encouraged to reach out to TCC Staff at the contact information on this report.
