RTPO Technical Advisory Committee Monday, November 1, 2021

The Technical Advisory Committee was called to order at 9:38 am by Tyler Bumbalough.

New Business:

- 1. Welcome and Introductions were completed.
- 2. September 13, 2021, Meeting Minutes
 - Scott Coleman moved a motion to accept the minutes as written and Steve McCall seconded. All in favor.
- 3. RTPO Capital Program and STBG Applications
 - Brad Bodenmiller provided an overview of the process timeline and funding available.
 - Melanie Runkle provided staff recommendations.
 - The group discussed what happens to the overall funding pot if projects come-in under budget. Melanie Runkle and Ben Wiltheiss advised it typically rolls-into the next application funding cycle. There was discussion about the time it takes for ODOT to close-out a project once it completes; it may take several months for awarded funding to make its way back to the overall funding pot.
 - The group discussed the projects, the amounts requested, and the associated activities.
 - The group discussed the application for a study to add two lanes along US68—CHP Two Lane Addition to US68. If a study is completed, it does not trigger ODOT to do the project. However, a study is needed to trigger the conversation. A safety study could be requested of ODOT, rather than doing a study through this funding pot.
 - Scott Coleman moved a motion to recommend approval to fund as following:
 - 1. LOG-CR18 Profile Improvements: Fund full request of \$151,713 for CO/CE with the understanding the requested amount will be

- reduced between today's TAC meeting and the Executive Committee decision. Any savings from the reduced amount will go to funding the CHP-Upper Valley Pike Widening request.
- 2. LOG-TR179 Widening (TR181-CR10): Fund full request of \$98,291 for CO/CE.
- 3. CHP-Urbana Bike Trail Crossing Safety Improv.: Fund partial request in the amount of \$44,900 for activity of PE and DD.
- 4. CHP-Urbana Woodstock Pike Reconstruction Design: Fund partial request in the amount of \$48,000 for activity of PE environmental and PE DD.
- 5. CHP-Upper Valley Pike Widening: Fund partial request in the amount of \$49,096 for CO. Additionally, any savings from the reduced amount of LOG-CR18 Profile Improvements will go to funding this partial request for CO.

 - South Main Street Study
 - Tyler Bumbalough reported on this item.
 - o Logan County
 - Trail Feasibility Study
 - Brad Bodenmiller would like to see a feasibility study done in Logan County from Bellefontaine to Huntsville. From there, we could look to Indian Lake and/or Belle Center.
 - Champaign County
 - St. Paris/Champaign Multi-Use Trail Feasibility Study
 - Tyler Bumbalough Steve McCall requested contact information for Burgess & Niple's point person.
- 5. Mobility Management and Transit Updates
 - There was no report on this item.
